In accordance with the *Bees Act* and regulation 57, this permit allows the beekeeper named above to sell or move live bees, including full sized colonies, queen bees, queen cells, nucleus colonies, packaged bees, brood frames, and its associated used equipment, from the operation shown above until the date of permit expiry. Inspection of a proportion of this beekeeping operation determined the eligibility requirements for issuance of this Queen and Nuc Permit were met.

The visual inspections resulted in finding of the following regulated pests and diseases within the operation,

The average varroa level for all other yards inspected were between 0% and less than 2%.

Please be aware of the following:

1. The Permit is not applicable to sales or movement of bees from yards found positive for American Foulbrood within the 2 previous years or yards with an average Varroa level greater than or equal to 2%. This Permit does not authorize the sale or movement of bees above those levels.
2. No Person shall receive of transport in any manner within Ontario any pest [*Bees Act* s.13.]. This permit does not include the transportation of any pests
3. Permit is issued based on inspection of a proportion of colonies within a proportion of yards in the beekeeping operation over a scheduled period of time. Not all yards within the operation are inspected.
4. Every person who sells bees must make a return to the Provincial Apiarist in writing stating the name and address of the buyer, the quantities of bees or package bees sold and the date of shipment of each quantity. The return shall be made within thirty days of the date of sale of the bees or package bees. [*Bees Act*, Ontario Regulation 57 s.4.] Subsequent Queen and Nuc Permits may not be granted if sales records are not submitted to the Provincial Apiarist.
5. Beekeepers are required to comply with all aspects of the *Bees Act* and its regulations.

This permit is valid from the date of issuance until December 31, 2021. This permit may be revoked at any time for non-compliance with the *Bees Act*, R.S.O. 1990, Chapter B.6. and regulation 57, for non-compliance with the conditions set by the Provincial Apiarist, or due to a change in the operation's pest or disease status.
